The Battle Ground Art Alliance invites artists, 18 years and older, residing in SW Washington, to enter the 2010 Spring Show and Sale. The Spring Show and Sale will exhibit fine art and fine craft.

ELIGIBILITY: All items considered must be of original design and made by the artist. No kits, commercially made items or reproductions will be accepted.

MEDIA ACCEPTED: Two dimensional (2D) such as oils, watercolors, acrylics, pastels, drawings, handmade prints (no reproductions), mixed media, collages, photography and art quilts. One piece may be no longer than 45" in any direction, including frame. All subsequent pieces may be no longer than 40" in any direction, including frame. All 2 dimensional works except art quilts must be securely wired for hanging. No sawtooth hangers or clips. **Work needs to be current and cannot have been entered in a prior Art Alliance show.**

Three dimensional (3D) such as jewelry, sculpture, pottery, glass, egg art, textiles, woodwork and garden art. Works must not exceed 40 lbs in weight.

SALES: We will promote sales and will accept a 25% commission on all sales. The price listed on the entry form will be used. Please include sales tax in your asking price. **You are responsible for compliance with state tax requirements.** Checks will be mailed to artists within 10 days.

AWARDS: 2D and 3D categories will each receive first, second and third place awards. Additional awards are best of show, artistic presentation, technical merit, originality and people's choice.

JUDGE: TBA

HOW TO ENTER: Bring work to the Community Center in Battle Ground on Friday, March 19th between the hours of 8 AM and 2 PM to be juried. **HAVE ENTRY FORMS FILLED OUT COMPLETELY AND LEGIBLY** for each piece entered.

ENTRY FEE: \$20.00 for the first piece and \$5.00 for each additional piece. **Maximum three pieces per artist.**

CONDITIONS: Every precaution will be taken to protect entries, however, the Battle Ground Art Alliance and the Battle Ground Community Center assume no responsibility in case of loss or damage. Your entry to the show gives the Battle Ground Art Alliance permission to use any photographic images taken of your pieces(s) of art only to promote the BGAA.

SATURDAY, March 20th: The exhibit will be open from 10 AM to 8 PM. The Artist Reception will be from 5 to 8 PM with awards presentation from 6:30 to 7 PM.
SUNDAY, March 21st: The exhibit will be open from 11 AM to 4 PM. Last minute customers for sales will be a priority. All work must be picked up between 4:15 and 5 PM sharp. Work left after 5 PM will be charged a storage fee of \$10. per day.
